What started as an idea in the summer of 2006 is on its way to being a vibrant academic association. In the past year, we have managed to get the organization registered as a non-profit scholarly association in the State of Ohio. Meanwhile, we have applied for and are awaiting federal tax-exempt approval.

The Kenya Scholars and Studies Association (KESSA) exists for the purpose of (1) Promoting scholarly, scientific and research work in or about Kenya in all scholarly disciplines and persuasions; (2) Promoting and facilitating cooperation through the exchange of ideas and meaningful dialogue among groups and/or persons engaged in scholarly, scientific, and research on Kenya; (3) Encouraging and

facilitating the dissemination of information, publications, and other scholarly works on Kenya and; (4) Organizing workshop panels, discussions, symposia, and conferences on Kenya.

The birth of KESSA is timely for two reasons. First, there is now a critical mass of Kenyan and non-Kenyan scholars who have a research interest in/on Kenya. Although many other forums of networking and collaboration exist, "there is no place quite like home".

KESSA would not be where it is without your support as members. For that I say, thank you. I'm also indebted to the hard work and dedication of the following people: The Interim executive that consists of Drs. Maurice Amutabi (Vice-president), Francis Koti (Secretary), and Gichana Manyara (Treasurer); Drs. Activities to Date

Several important events have taken place since the inception of this association. These include:

August 2006 – Dr. Kefa Otiso compiles a list of known Kenyan scholars (faculty and graduate students) in the US and approaches them with a proposal to form an academic association for Kenyan scholars and other scholars with interest in Kenya. The proposal receives overwhelming support and soon after, an online listserv is established in *Yahoo* to facilitate communication and discussion on the proposed organization. The listserv soon grows into a discussion forum.

November 17, 2006 – At the annual meeting of the African Studies Association (ASA)

conference in San Francisco, CA, the idea of Kenya Scholars and Studies Association (KESSA) is formally tabled by Dr. Maurice Amutabi to a group of scholars, both Kenyan as well as those interested in Kenya. The informal advisory committee consisting of Dr. Maurice Amutabi, Dr. Francis Koti, Dr. Gichana Manyara and Dr. Kefa Otiso is asked to lead the association on an interim basis and to spearhead its registration.

March, 2007 – The interim leadership completes a draft constitution. The constitution stipulates the organizational structure including: name, purpose, membership, structure and composition, duties and responsibilities.

April 4, 2007: KESSA obtains Employer

Identification Number (EIN)

June 4, 2007: KESSA is registered as a nonprofit in the State of Ohio

August 21, 2007: Application for tax exempt status is submitted to the federal government (Status: Under consideration)

September 6, 2007: KESSA applies for affiliation with the ASA (Status pending).

October 19, 2007: ASA meeting in NYC. KESSA holds a meeting led by Dr. Amutabi. Draft constitution is tabled and ratified pending some amendments, KESSA solicits for membership dues, plans for inaugural KESSA conference, and a KESSA journal begin to take shape.

Upcoming Events and Deadlines

March 31, 2008 – Registration deadline for recognition as a KESSA founder member. Please pay your dues on time to avoid a last minute rush. All registered members by **March 31, 2008** will receive a founder member's certificate. Please send membership dues to the President or Treasurer using the attached form. Regular membership is \$50 and Students is \$25.

April 15, 2008 – The second volume of our Newsletter will be released. Please forward to us any important information you think should be included in our Newsletter. All items must be received by the Secretary by March 15, 2008.

July/August, 2008 – First inaugural KESSA Conference. The actual date and venue for this conference have not been

set. The venue and date will be relayed to all members shortly along with the request for abstracts.

November 13-16, 2008 – Annual Meeting of the African Studies Association (ASA) will be held in Chicago, IL.

Please let us know of any other upcoming events that may be of benefit to members and we will publish them in the next edition of this Newsletter.
